in conjunction with industry associations and state and regional chambers of commerce.

In 2005, Mr. Mullikin led a team of researchers and environmental experts on an Antarctica expedition studying the effects of climate change on the polar regions. He told the story of this expedition in a video documentary, *Climate Change: Global Problems, Global Solutions*, which received widespread acclaim in both business and environmental circles, and was broadcast on New Hampshire Public Television, with a Boston-area viewership of more than 2.4 million households. He has led subsequent expeditions to the Namib Desert of Africa, the Amazon River Basin of Peru, and the Great Barrier Reef of Australia to highlight the global effects of climate change.

Mr. Mullikin formerly served with the United States Army Judge Advocate General Corps, USAR, where he served as the Assistant Staff Judge Advocate for the 360th Civil Affairs Brigade (Airborne), United States Army Civil Affairs and Psychological Operations, United States Army Special Operations Command. For his service, he was awarded, among other honors, the Meritorious Service Medal, Army Achievement Medal, and Global War on Terror Service Medal. He has also received the Order of the Palmetto, the highest civilian honor bestowed by the State of South Carolina.
