## **APEX MENTORING PROGRAM**

## An Organic Approach to Mentoring

DeeDee Lott of Compass Group USA, Inc. and Luis M. Lluberas of Moore & Van Allen are participants in the MCB Apex Mentoring program. Apex, now in its second year, is designed to encourage and support the ascension of minority attorneys to senior positions within Charlotte-Mecklenburg's law firms. The program matches minority associates from law firms who have been in practice between three to seven years with tenured in-house counsel from a law department, specifically within firm and legal department signatories to the MCB's Diversity and Inclusion Committee's Call to Action.

DeeDee and Luis get together on a monthly basis to get to know each other better on a personal level while discussing varied topics, including insights into the practice of law and how to balance a vibrant, demanding professional career with the joys of family life. This has allowed DeeDee, a female litigator of Filipino descent, and Luis, a male bankruptcy attorney of Puerto Rican descent, to highlight their diverse backgrounds and build a substantive mentoring relationship.

DeeDee and Luis have both enjoyed their relationship and would like it to endure well past the formal end of this year's Apex program. With that objective in mind, they have let their mentor-mentee relationship

grow organically and without specific "task based" goals. For Luis, the organic approach is vital since his belief is that "a mentoring relationship blossoms when you get to know the experiences underpinning the other person's opinions and advice." As DeeDee stated, "I think we both learn from each other as we share our insights and experiences. It helps that our conversations come so naturally." For both of them, a gradual approach to their mentor-mentee relationship has revealed that their personalities and backgrounds provide excellent fodder for discussion topics that ultimately highlight their common interests and work ethics. DeeDee and Luis agree that, as Luis puts it, "I didn't think that I would gain so much insight from a mentor with such a dissimilar background, but that initial assumption could not have been more off cue."
