Throughout the summer, mentors connect, guide, and teach their mentees throughout the summer and in the years to follow.

### 1L Summer Program Opportunities

#### MVA Diversity Conference

Moore & Van Allen's annual Diversity Conference is a one-day seminar designed to introduce 1L and 2L law students to leaders and career opportunities in the legal industry. Students are selected through a competitive application process and gain exposure to the climate of diversity in the legal industry through various networking opportunities, interactive panels, and presentations from MVA members, clients, and other leaders in the legal profession.

#### MVA Diversity Scholarship

Launched in January 2019, Moore & Van Allen's Diversity Scholarship Program is a unique summer employment opportunity for law students. Open to all first-year and second-year law students, we evaluate candidates based on their academic performance, communication skills, demonstrated leadership qualities, work experience, and community involvement. Selected students will have the opportunity to participate in the firm's 10-week summer associate program and may receive up to \$35,000 in additional scholarship money.
